CONDITIONS OF ISSUANCE FOR ALL WOLF MOUNTAIN SEASON PASSES

As a Season Pass Holder, Wolf Mountain looks to you to help us maintain a tradition of safe skiing/snowboarding/mountain biking by setting a safe example and encouraging others to do the same. Listed below are rules and regulations to make your skiing/snowboarding/biking experience safer and more enjoyable. This is only a partial list, use common sense and good judgment. If you are in doubt please ask our Ski Patrol.

SKIER'S/RIDER'S RESPONSIBILITY CODE

1. Ski/snowboard/biking under control at all times and in such a manner that you can stop to avoid other skiers or objects.
2. When skiing/snowboarding/biking downhill or overtaking another skier, avoid the skier below.
3. Do not stop where you obstruct a trail or where you are not visible from above.
4. When entering a trail or starting downhill, yield to others.
5. Use ski brakes or other approved retention devices to help prevent runaway skies/snowboards.
6. Observe all posted signs and warnings. Keep off closed trails and out of closed areas.
7. Prior to using any lift, you must always have the knowledge and ability to load, ride and unload safely.

Violations of the following safety procedures will result in legal prosecution and/or loss of lift privileges without compensation.

1. Skiing/snowboarding/biking too fast or recklessly.
2. Skiing/snowboarding/biking beyond CLOSED AREA signs into a Closed Area.
3. Skiing/snowboarding/biking beyond CLOSED AREA AVALANCHE DANGER signs into an Avalanche Area
4. Jumping out of chairlifts.
5. Abusive or rude language and/or behavior.

This Season Pass shall remain the property of Wolf Mountain and is non-transferable, non-refundable and is not for resale.

All lift privileges granted hereby are to the person named hereon only. Use of this Season Pass by anyone else will result in immediate loss of all lift and skiing/snowboarding/biking privileges without compensation and shall constitute fraud by both parties.

Day passes will not be issued if your pass is lost, stolen or forgotten. There will be a service charge of \$50 to replace this Season Pass and will only be reissued once if it is lost or stolen. This service charge is non-refundable.

This season pass is valid only during the current ski season and does not authorize any other recreational or other use of the Ski Area, or use other than during the ski season. Under the Utah Code SS 57-14-7, any recreational use of the Ski Area other than for skiing, or other than during the ski season, is at your own risk.

AGREEMENT AND RELEASE OF LIABILITY

THIS IS A LEGALLY BINDING CONTRACT. PLEASE READ CAREFULLY BEFORE SIGNING.

I am aware that the sport of skiing/snowboarding/biking in their various forms, (hereafter "skiing") involves the risk of property damage, injuries and possible death, and I agree to assume all such risks which may result from skiing or use of the facilities at Wolf Mountain. I agree that hazards exist throughout the ski area and may be unmarked and occur without warning. I agree, for the issuance of a pass and use of the ski area, to expressly assume and accept all such risks of skiing at Wolf Mountain. (Initial)_____

I, my heirs, distributees, guardians, legal representatives, or assigns agree to release from any legal liability and to never file a claim or suit against Wolf Mountain, Wolf Creek Utah, or any officer, member, affiliated organization, agent or employee for any injuries or death caused by or resulting from my participation in the sport of skiing, or use of the facilities of Wolf Mountain, whether such injury or death was caused by my own or another skier's/rider's negligence or from any other cause. I authorize any of the Released Parties to take photographs and videos of me during my participation in Activities and consent to the publication of such photographs or videos by any of the Released Parties for advertising, promotional, or marketing purposes. I agree that such photographs and videos, and any photographs or videos I send to any of the Released Parties subsequent to my participation in Activities will be the property of Wolf Mountain. I have carefully read the conditions of issuance and the agreement and release of liability and fully understand its contents. I have also received, read, and agree to the policies of Wolf Mountain. I am aware that this is a contract between myself and Wolf Mountain and/or its affiliated organizations, and sign it of my own free will.
